



Financial Undertaking for a Student

Supporting information for an application for a student visa



About the information you provide

The information about you on this form is collected to determine your eligibility to be a guarantor for a student.

So that we can confirm that you have sufficient funds to be a guarantor you must either:

- provide bank statements (original, or certified copies for the previous three months, or
- ask your bank to complete 'Section E: Bank confirmation'.

If you are supporting a student who is already in New Zealand, you must be a New Zealand citizen or residence class visa holder.

When you have completed sections A–D of the form, and your bank has completed 'Section E: Bank confirmation' if necessary, please return it to the student.

The main recipient of the information is Immigration New Zealand, Department of Labour, but it may also be shared with other Government agencies, which are entitled to this information under applicable legislation.

The address of Immigration New Zealand is PO Box 3705, Wellington, New Zealand. **This is not where the application should be sent.**

The collection of the information is authorised by the Immigration Act 2009 and the Immigration Regulations made under that Act. The supply of the information is voluntary, but if you do not supply it then the application may be declined.

Any person who is in New Zealand has a right to access the information about them held by Immigration New Zealand and to ask for any of it to be corrected if they think that is necessary.

When filling in this form, please print clearly in English using CAPITAL LETTERS.

The guarantor (the person giving the financial undertaking) must complete sections A, B, C and D.
